

COOLIDGE ISAT INFORMATION 2011-2012

Strengths

- Systemic structure and motivation have been increased throughout the building
- Character Plus has assisted in increasing student autonomy and involvement, raising attendance rates and leading to even better test scores
- We have two tutoring programs, RTI Reading and SIUE Practice Student Tutoring, in addition to Teen Reach. These programs combined are providing extended academic services to approximately 200 students
- We partner with both Big Brothers/Big Sisters and Chestnut Health in providing direct contact services during the school day
- We are expanding the use of Discovery Education assessment and evaluation tools.
- Our scores have improved every year, but the state assessment levels percentages keep rising!
- The building-wide attendance percentage was 91%. This is the first time in four years that Coolidge Middle School has met AYP.

Areas for Planned Improvement

- Coolidge did not make the AYP (Annual Yearly Progress) in Math. The building-wide Math percentage is 79.8%; this was an increase over last year (However 92.5% is needed for AYP)
- Coolidge Middle School building-wide reading percentage is 70.4% (Again 92.5% is needed for AYP)
- Attendance for economically disadvantaged students was 89.7% an increase again, but (91% needed for AYP)
- The students with disability reading percentage is 36.4% (Safe Harbor is 41.2%)
- Coolidge is in the 5th year of Academic Watch Status in regards to AYP Federal and State status.

Our major focus will be to continue to increase the rigor of our curriculum. We will also expand the Character-Plus Program. Rewards and consequences will be more vigorously pursued to improve school wide structure, discipline and motivation. Recognition of outstanding students will increase, and we will attempt to get more students participating in all school activities. Increased efforts have been and will continue to be made to reduce the number of chronically truant students.

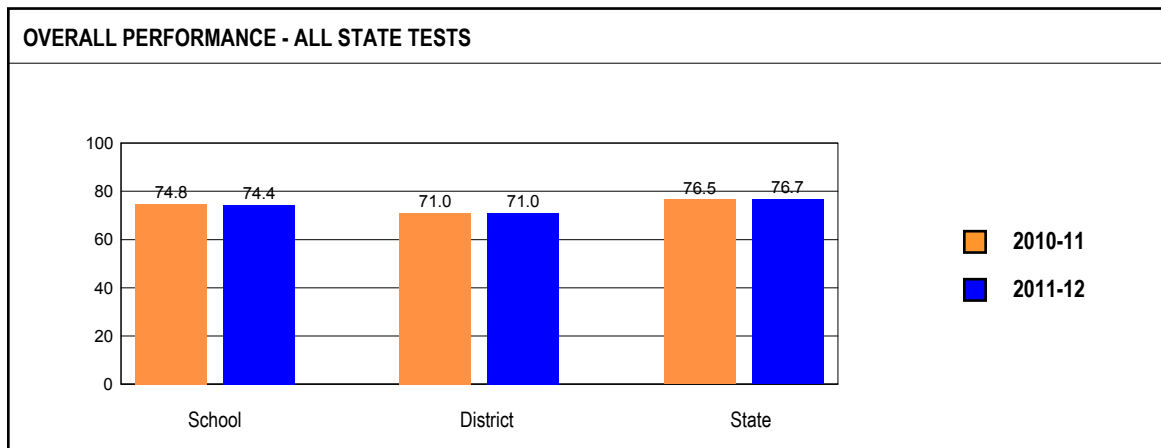

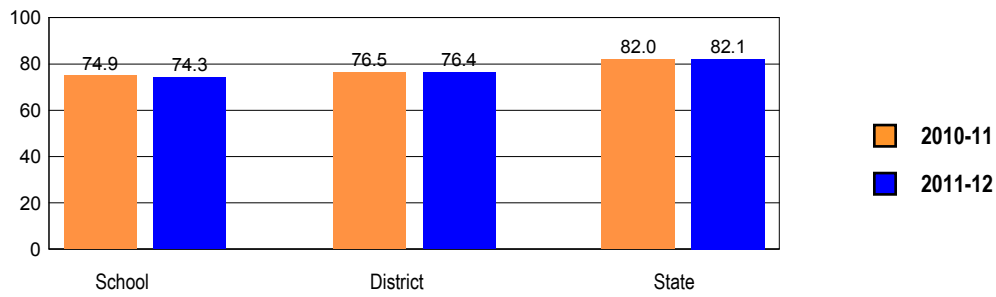
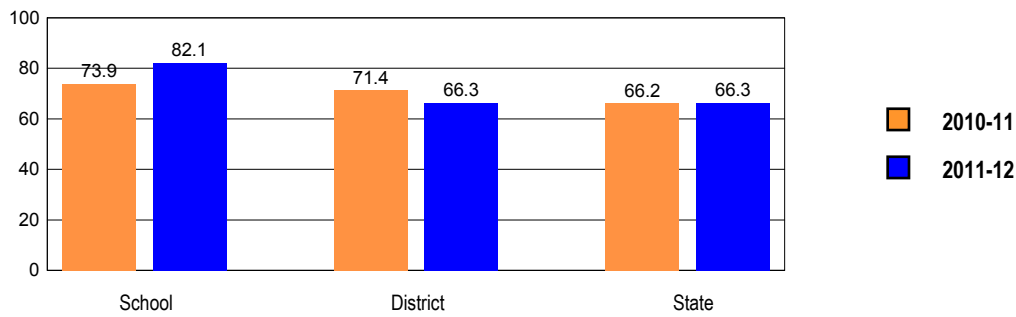

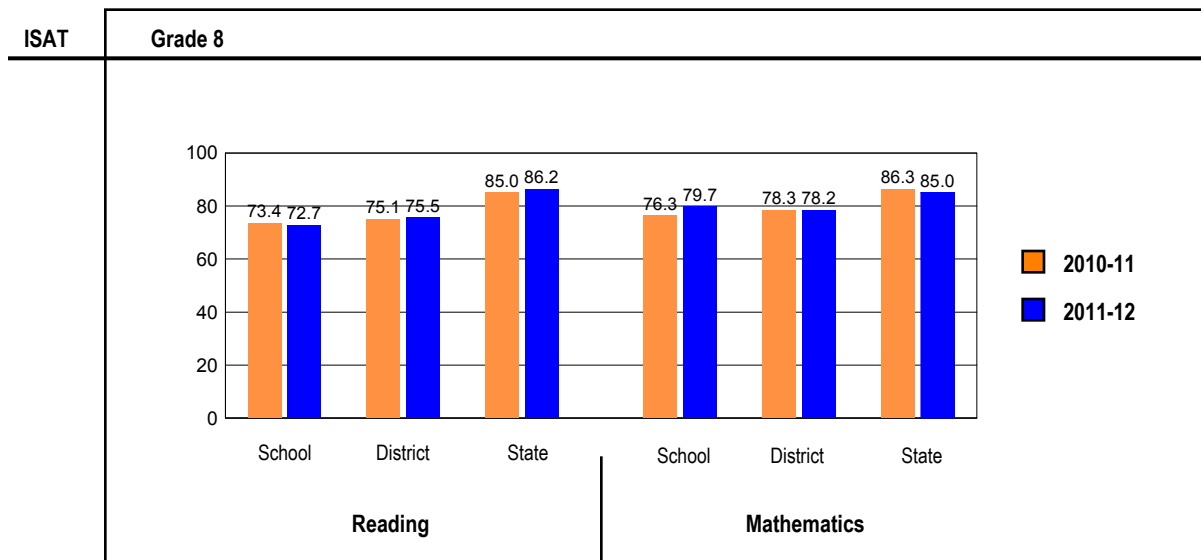
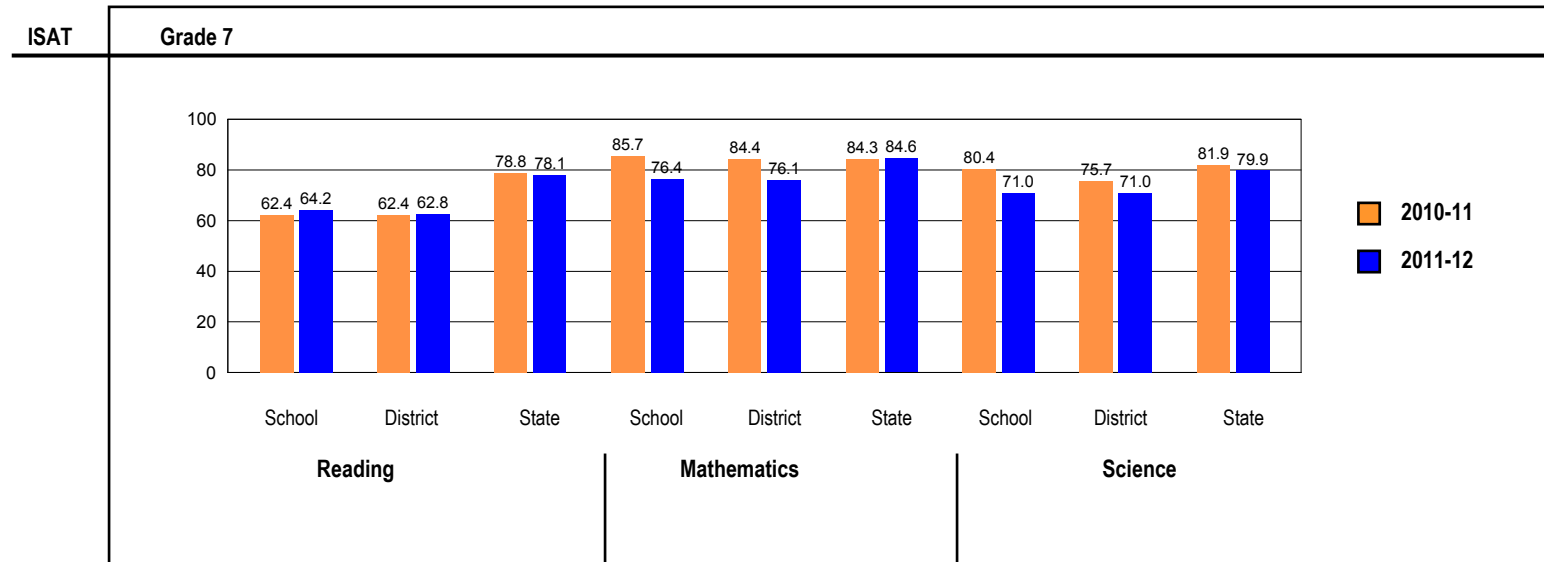
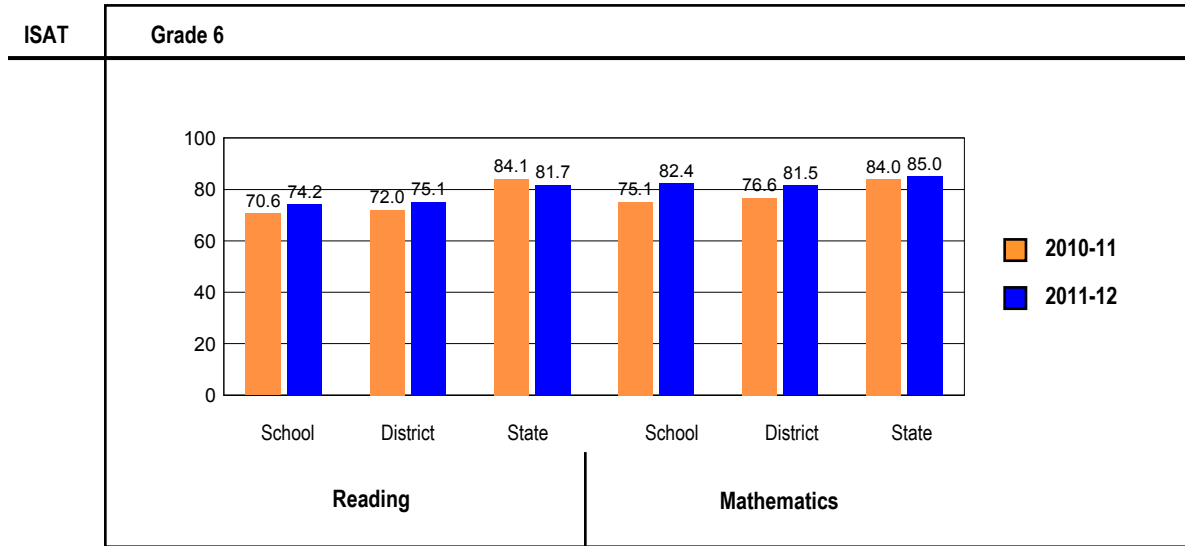

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.
